



NOTICE FOR AN OPEN NATIONAL INVITATION TO TENDER

**FOR THE REHABILITATION OF AN ELEVATOR OF 630KG, 08 PERSONS LABORATORY SIDE
AT ESSOS HOSPITAL CENTRE**

FUNDING : CNPS Budget

1. Purpose of the Invitation to Tender

As part of the facilitation of the mechanized transfer from one level of the building to the other, of users, patients and staff, as well as movable property, the Director General of CNPS launches an Open National Invitation to Tender for the rehabilitation of an elevator of 630kg which can carry eight people at Essos hospital Centre (CHE). The services to be carried out are contained in the Particular Technical Specifications (CCTP).

2. Consistency of services

Machinery

- Complete replacement of control cabinets;
- Replacement of a traction motor;
- Revision of the jaw brakes and braking system;
- Replacement of traction sheaves;
- Replacement of all wear parts.

Bearings

- Replacement of door locks;
- Installation of bearing position indicators;
- Replacement of door pads, control knobs, suspension rollers;
- Replacement of all wear parts

Ducks and cabins

- Replacement of door operators;
- Replacement of photoelectric cells;
- Re-dressing of cabins x;
- Replacement of all wear parts;
- Replacement of the control, ringing, door opening buttons;
- Replacement of traction cables.

The rehabilitation necessarily involves the replacement of faulty or worn parts. Supplied parts must be provided with a supplier's certificate and a warranty. The adaptation of parts to the installation, if necessary, is the responsibility of the service provider, who must give a guarantee of a duration at least equal to that of the manufacturer of the original parts.

3. Execution deadline

The time limit set by the Project Manager for carrying out the work referred to in this invitation to tender shall be **ten (10) months**.

4. Allotment

The work is united in one lot.

5. Estimated cost

The estimated cost of the operation at the end of the preliminary studies is **CFA francs, excluding taxes 39,660,000 (thirty nine million six hundred and sixty thousand), that is CFA francs all taxes included, 47,294,550 (Forty seven million two hundred and ninety four thousand five hundred and fifty)**.

6. Participation and origin

Participation in this invitation to tender is open to companies with proven experience in the field of installation and maintenance of elevators, and having a competent and experienced technical team.

7. Funding

The work under this invitation to tender is financed from the CNPS program budget 2013-2017, on the budget allocation line 9-2D2206.

8. Provisional security

Each tenderer must attach to his administrative documents a bid bond drawn up by a bank of the first order approved by the Ministry of Finance and listed in Exhibit 10 of the CAD, specifying the amount of CFAF 800 000 (eight hundred thousand).

Such security shall be valid for thirty (30) days beyond the original date of validity of the bids.

9. Consultation of the Bidding Documents

The file can be consulted during working hours at the Contracts Service located at the 9th floor room 903, CNPS Yaoundé Independence Square, as soon as this notice is published in the Journal of Contracts (JDM).

10. Acquisition of the Bidding Documents

The file can be obtained at the place indicated above when publication of this notice, against the payment of a non-refundable sum of **CFA francs 60 000 (sixty thousand)** in the CAS-ARMP special account n ° 335988 opened in the BICEC agencies.

11. Submission of Bids

Each tender in French or English in seven (07) copies, one (01) original and six (06) copies marked as such, must be received by the Contracts Service no later than **21 November 2017** at 11am, local time and must bear the mention :

12. Admissibility of Bids

Under penalty of rejection, the documents required in the administrative file must be filed in original or certified

copies by the issuing department **or an administrative authority**, in accordance with the provisions of the Supplementary Regulations.

They must be dated less than three (03) months before the original date for submission of tenders or have been established after the date of signature of the Notice of Invitation to Tender.

Any incomplete tender in accordance with the requirements of the Bidding Document shall be declared inadmissible. In particular, the absence of the bid bond issued by a first-rate bank approved by the Ministry of Finance or the failure to respect the models of the tender documents will lead to the rejection of the tender, offer without any recourse.

13. Opening of folds

The opening of bids will be done in a single phase.

The opening of administrative documents and technical offers will take place **21 November 2017 at 12:00**, local time, by the Internal Procurement Commission of the National Social Insurance Fund, in the meeting room of the said Commission on the 4th floor, room 416 of the CNPS Building located at Kennedy Avenue. Only tenderers may attend this opening session or be represented by a duly mandated person of their choice.

14. Evaluation criteria

14.1 Eliminary criteria

The Elimination Criteria are:

- Absence of an administrative document at the opening of the folds;
- False declaration or falsified document;
- Absence of a quantified unit price in the financial offer;
- No validation of at least 70% of the evaluation criteria;
- Non-compliance with CSR standards:
 - Number of staff members affiliated with the CNPS: 3 or more (online declaration for the last 3 months), detailed list of personnel with their individual registration with CNPS, attach the Clearing Certificate certifying that the payment of contributions has been updated;
 - Fair remuneration (respect of the SMIG: join DIPE or salary statements);
 - Respect for the principle of the promotion of gender: justify at least 20% of feminine gender in the workforce (join the DIPE, the staff list and the gender report);
 - Liability insurance covering the current financial year (please enclose insurance policy).
