1. Purpose of the Invitation to Tender

As part of the preservation and perpetuation of the operating assets of the National Social Insurance Fund, the Director General is launching an Invitation to Tender for the partial renovation of the paintings in the Essos Hospital Centre.

2. Consistency of work

The work covered by this Invitation to Tender concerns in particular the following operations:

- The prerequisites for the installation of the site, bringing in and withdrawing the equipment and tools, mobilizing the personnel, setting up the warehouse space, securing the site and scaffolding.
- Preparation of surfaces to be painted by scraping, dusting, ginning, sanding and washing with plenty of water, including all types of crack sealing, waterproofing and mould treatment.
 - Supply and application of the two coats of MAESTRIA acrylic water-based paint (Vinylex),including all 20% dilution and colouring requirements (depending on the user's choice):
 - Supply and application of two coats of water-based paint such as MAESTRIA acrylic (Latexor) including all 20% dilution and colouring requirements (depending on the user's choice).
 - Supply and application of oil paint type MAESTRIA solvent (Ikartac) including all subjections;
 - Preparation of wooden surfaces by sanding and dust removal;
 - Supply and application of two coats of marine varnish on wooden structures thus prepared, including any dilution requirements.

3. EXPECTED RESULTS

The project seeks to improve the working environment and the institution's brand image.

4. METHODOLOGY

The procedure will follow the following steps:

- brought in and removal of site installation equipment;
- production of an execution schedule;
- execution of the preparatory work;
- execution of the above-mentioned work;
- acceptance of the work.

5. PROVIDER PROFILE

The contractor must have proven experience in the field of civil engineering works, have a competent and experienced technical team composed of qualified technicians and maneuvers.

Project leader (Senior civil engineering technician Bacc+2 at least or equivalent), Experience at least 03 (three) years; having completed at least two (02) projects in the field);

Work Monitor: (Civil engineering technician (Bacc at least or equivalent), experience of at least 02 (two) years, having completed 01 (one) project in the field;

Maneuvers.

In addition, it must have significant financial resources and be able to:

- provide and present the list of equipment to be used;
- specify the origin, quality and references of the materials;
- provide the technical data sheet of the products offered;
- specify the duration and warranty conditions of the equipment and installation;
- meet CSR requirements.

6. EXECUTION DEADLINE

The deadline, subject to this operation is **three (03) months**.

7. PLACE OF EXECUTION

The work will be carried out in Yaoundé (CHE).

9. Estmated cost

The estimated cost of the operation at the end of the preliminary studies is CFAF 38,395,218 (thirty-eight million three hundred and ninety-five thousand two hundred and eighteen thousand).

10. Participation and origin

Participation in this Call for Tenders is open to any company, a legal entity under Cameroonian law, with proven experience in this type of work.

11. Funding

The works covered by this Invitation to Tender are financed by the 2018-2022 programme budget of the National Social Insurance Fund for the 2018 financial year on budget line **9-2D2206**, in accordance with programme **P105**.

12. Tender Deposit

Each Tenderer must attach to his administrative documents, a Tender Deposit issued by a first rate bank approved by the Ministry of Finance, specifying the amount of **915,000** (**nine hundred and fifteen thousand**) CFA francs. The said deposit shall be valid for thirty (30) days beyond the original date of validity of the offers. With the exception of the time limit referred to above, the deposit shall cease to have effect, even in the absence of release, unless the Director General has duly notified the other party

that he has not fulfilled all his obligations. In this case, the guarantor's undertaking may be terminated only by release issued by the Director General.

16. ADMISSIBILITY OF TENDERS

Under penalty of rejection, the required documents in the administrative file must be produced in originals or certified true copies by the issuing Service or an administrative authority, in accordance with the provisions of the Specific Rules of the Invitation to Tender.

They must be less than three (03) months preceding the original tender submission date or have been established after the date of signature of the Tender Notice.

Any incomplete Tender in accordance with the requirements of the Tender Documents shall be declared non-responsive, in particular the absence of the Tender Deposit issued by a first-class bank approved by the Ministry of Finance.
