- I. Within the framework of the Request of Quotation procedure, the Director General of the National Social Insurance Fund hereby launches an open consultation with companies operating in the area of the services referred to above.
- II. For this purpose, bidders must consult the characteristics of materials and equipment to be acquired in the Request of Quotation file at the Contracts Service, CNPS building located at the Independence Square, room 903, tél 675 13 21 06/696 54 31 32 upon presentation of the receipt of payment of the non-refundable sum of **25,000 (twenty five thousand) CFA francs** in **the ARMP Special Assignment Account opened at BICEC**.
- III. The estimated cost of the project shall be **CFA Francs 14,991,000** (fourteen million nine hundred ninety-one thousand) or **CFA Francs TTC 17,876,767** (seventeen million eight hundred and seventy-six thousand seven hundred and sixty-seven).
- IV. The closing date for submission of bids shall be on the **19 October at 11 am**. These offers will be submitted in a sealed envelope addressed to CNPS with the mention:

 - Liability insurance covering the current financial year (enclose insurance policy).

In addition to the valid administrative file duly certified, bids produced in seven (07) copies; one (01) original and six (06) copies marked as such will be calculated excluding and including Taxes accompanied with models of the signed submission letter and jobbing order.
